Shut-in of production and other alternatives must be used whenever possible to keep flaring operations to a minimum.	p.4, S. 6.1, Paragraph 6 p. 13, Appendix, bullet 2	Confirm that a flare permit was applied for and issued prior to any flaring occurrences.	Completed. Flaring was only intended to be done during the completion of the well. Due to the well not being completed or put on production, Intrepid did not submit a flaring permit application. It was confirmed with the EUB's Grande Prairie office that flaring did not take place. The well was abandoned and cement plugs were placed on December 10, 2005 and the rig was released on December 11, 2005. Flaring as a result of production never took place.

The well was abandoned and cement plugs were placed on December 10, 2005 and the rig was released on December 11, 2005. So no future flaring will occur.
